COMPETENCY MODEL FOR CUSTODIAN SUPERVISOR (3176)

The following competencies have been identified as those that best separate superior from satisfactory job performance in the class of **Custodian Supervisor**. (Numbers refers to the order of the competencies in the Competency Bank.)

- 1. Reading Comprehension
- 3. Judgement and Decision Making
- 8. Safety Focus
- 20. Job Knowledge
- 22. Computer Proficiency
- 28. Supervision
- 33. Interpersonal Skills
- 47. Written Communication

On the following pages are descriptions of each competency, including a definition, the level of the competency required for the class (italicized, bolded, and underlined), examples of behavioral indicators, and satisfactory and superior performance levels.

1. **READING COMPREHENSION** – Comprehends and correctly applies information presented in written form. Makes correct inferences; draws accurate conclusions.

Level of Competency Required by Job:

Level 1: Concrete, specific job-related information (work orders; instructions; material/equipment labels)

Level 2: <u>General information related to field of work and assignments;</u> (articles in trade publications; technical/instructional manuals; memos; letters; e-mails; reports)

Level 3: Abstract/complex information (highly technical articles/ reports in specialized area; legal or other regulatory material)

Examples of Behavioral Indicators:

- Follows written instructions correctly.
- Learns information presented in writing.
- Identifies relevant written information.
- Interprets written legal regulatory material accurately.

Performance Levels:

Satisfactory	<u>Superior</u>
Reads instructions correctly. Learns from manual and other printed material.	Learns from manual and may answer others' questions. Explains information presented in written form to others.

3. JUDGMENT AND DECISION MAKING – Accurately assesses situations, seeks new information if necessary, and applies all available information to reach sound conclusions/formulate effective response.

<u>Level of Competency Required by Job</u>:

Level 1: Training and guidelines needed to respond to immediate situations within very specific function are provided (or supervisor available to assist).

Level 2: General information and guidance to assist in responding to a variety of situations across a range of circumstances are provided.

Level 3: Little guidance available for responding to a wide range of complex situations with far-reaching and/or enduring consequences.

Examples of Behavioral Indicators:

- Effectively responds to atypical situations.
- Asks questions or otherwise obtains additional relevant information to make a decision.
- Formulates a decision and necessary actions based on available facts.
- Correctly infers appropriate response based on information provided and existing policies, personal experience, and/or consultation with others.
- Discusses conclusions/possible responses with others before taking action as necessary.
- Considers impact of decisions on all affected parties.

Performance Levels:

<u>Satisfactory</u> <u>Superior</u>

Correctly assesses routine and unusual situations and reaches appropriate conclusions for actions needed. Obtains additional information and/or consults with others as necessary.

Evaluates new situations accurately to establish an appropriate response or plan of action. Recognizes the impact on all affected parties, as well as the possible ramifications and/or repercussions of setting a precedent.

8. SAFETY FOCUS – Performs work in a way that minimizes risk of injury to self or others.

Level of Competency Required by Job:

Level 1: Maintain awareness of unsafe conditions and actions to avoid injury.

Level 2: Follow safety rules/procedures; avoid known hazards in the work

environment.

Level 3: Carefully follow safety rules and procedures and consistently

use all necessary safety equipment.

Examples of Behavioral Indicators:

- Wears seat belt.
- Ensures safe physical work environment by taking actions such as eliminating unstable stacks of materials, closing drawers so filing cabinets will not tip over, and keeping pathways clear of tripping hazards.
- Reviews safety procedures before beginning each job with known hazards.
- Follows safety procedures while performing work even when it takes more time.
- Uses safety equipment such as goggles, gloves, and earplugs as required or warranted.
- Frequently checks safety equipment for proper condition and operation.

Performance Levels:

Satisfactory Superior

Maintains awareness of personal safety to avoid injury or property damage during all work activities.

"Safety first." Places avoidance of injury or property damage above all other job requirements. Mentions the need to follow safe work practices to co-workers. Actively seeks ways to avoid injury.

Safety Focus Areas

- 1. Knowledge of safety practices related proper lifting and carrying techniques sufficient to ensure that subordinates perform work safely.
- Knowledge of fire prevention and control, including types of conditions that present fire hazards and use of fire alarms and extinguishers, sufficient to recognize and correct fire hazards and quickly report and, if possible and safe to do so, extinguish fires.
- 3. Knowledge of work site security procedures, such as security badging requirements, locking entrances, recognizing evidence of break-ins, and reporting fires and/or security problems, sufficient to maintain a safe work environment and quickly address any security problems.
- 4. Knowledge of safety procedures and potential hazards associated with various types of cleaning materials and/or chemicals, including those listed in Safety Data Sheet (SDSs), such as proper disposal, toxicity levels, and/or protocols if ingested, sufficient to provide applicable safety information to staff and/or identify unsafe practices related to using cleaning materials and chemicals.
- Knowledge of fall protection safety equipment and procedures, such as guardrails, handrails, tripod usage, non-slip surfaces, ladders safety, and use of safety harness systems, sufficient to reduce the likelihood of falls and ensure that subordinates perform work safely.

20. JOB KNOWLEDGE – Knows information required to perform a specific job. Includes both widely available courses of study (for example, chemistry, human resources management, graphic arts) and City-specific information (parking regulation and ticketing practices; purchasing procedures; provisions of the City Charter).

<u>Level of Competency Required by Job</u>:

Level 1: Knowledge is concrete, factual, and/or procedural and may be defined by the organization. Situations in which it is applied are quite consistent.

Level 2: Knowledge is substantive and may be defined by an external trade, field, or profession. Situations in which it is applied vary and, as such, require breadth and depth of understanding.

Level 3: Knowledge is abstract, conceptual, and/or complex and may be supported by a well-defined academic discipline or authoritative sources (e.g., laws, ordinances, government guidelines/regulations/ codes). Situations in which it is applied may vary greatly or be novel.

Examples of Behavioral Indicators:

- Performs work correctly/avoids technical (job content related) errors.
- Answers technical questions about work accurately.
- Asks few technical questions about the performance of routine work activities.
- Offers advice ("coaching") to new employees regarding their work.
- Develops training programs for other employees.
- Sought out as a source of information by others.

Performance Levels:

<u>Satisfactory</u> <u>Superior</u>

Sufficient job knowledge to perform work correctly independently. Answers technical questions about work correctly.

Expertise in technical job information sufficient to serve as a resource to others. May develop training manuals/ programs and/or give internal and/or external presentations related to work.

Job Knowledge Areas

- 1. Knowledge of building cleaning methods, such as proper disposal of waste, disinfecting public areas, and maintaining restrooms, sufficient to instruct staff on the proper cleaning of various facilities and surfaces, including wood, glass, porcelain, tile, and carpet.
- 2. Knowledge of cleaning materials and/or chemicals, such as green chemicals and disinfectants, sufficient to instruct staff on the proper mixing and use of materials and/or chemicals.
- 3. Knowledge of the proper use and care of custodial equipment, such as vacuum cleaners, power scrubbers and buffers, and carpet shampooers, sufficient to instruct subordinates on the safe and proper operation, care, and maintenance of custodial equipment.
- 4. Knowledge of building machinery and equipment, including restroom facilities and lighting, sufficient to ensure proper cleaning and prompt reporting or repair of maintenance problems.
- 5. Knowledge of inventory control methods used for custodial supplies and equipment, such as stock keeping and ordering, sufficient to maintain accurate inventory records and to maintain appropriate quantities of supplies in stock.

22. COMPUTER PROFICIENCY – Uses computer hardware and software optimally to perform job tasks efficiently and effectively.

<u>Level of Competency Required by Job</u>:

Level 1: <u>Understand and use the basic function(s) of computer hardware</u> and software to perform work.

Level 2: Advanced understanding and use of function(s) of all necessary computer hardware and software to perform work.

Level 3: Expert understanding and ability to use all necessary computer hardware and software for the full range of their functions.

Examples of Behavioral Indicators:

- Correctly uses all necessary computer hardware (for example, keyboard, mouse, external storage devices, scanner, printer).
- Correctly and efficiently uses all necessary computer software (for example, wordprocessing, spreadsheet, and database/analysis programs and specific-purpose programs to perform work.
- Performs work with a minimal number of steps (separate computer operations).
- Uses various means of storing and backing-up work as appropriate to the access requirements (need to share) and sensitivity/security concerns.

Performance Levels:

<u>Satisfactory</u> <u>Superior</u>

Correctly uses all necessary computer hardware and software. Learns to use new hardware and software readily. Does not perform work manually when more efficient means via computer are available.

Optimally uses all required computer hardware and software. When alternatives exist, selects the best way to perform work on the computer. Coaches others (or provides formal training) in computer use to perform

SPECIFIC COMPUTER PROFICIENCY REQUIRED

1. Microsoft Word

- Proofreads [printout or on screen] documents and tables
- Edits (makes changes to) documents and tables
- Stores files in various locations

Using features that include: Copy; Cut and Paste; Page Numbering; Numbering; Highlighting; Spell Check; Grammar Check; Search and Replace; Save As; Convert to pdf/other version of program; Undo/Do; Print; Margins; Tabs; Font/Font Size; Justification; Line Spacing; Columns; Page Setup

2. Internet/Intranet

- Uses internet/intranet to search for and/or post information
- Submitting work orders

3. Email

 Composes (writes) emails; reads emails for own use or to forward to other person(s)

- **28. SUPERVISION** Ability to assume direct responsibility for all aspects of the performance of a work group, which requires knowledge and/or ability in the areas of:
- Planning and goal setting
- Creating a safe and positive work environment
- Establishing standards and training employees
- Motivating employees and teambuilding
- Performance Management (assigning, monitoring, facilitating, reviewing and evaluating work, and providing feedback)
- Supporting and developing employees through delegation and participation
- Taking disciplinary action including progressive discipline
- Provisions of employees' MOU's and handling grievances
- Legal requirements including EEO, ADA, FLSA, FMLA, and Workers' Compensation provisions
- Civil Service Commission Rules and Policies related to the management of employees
- Administrative Code provisions related to the management of employees
- Budget processes sufficient to request and justify expenditures in a correct and timely manner

Level of Competency Required by Job:

- Level 1: Supervises small workgroup of employees performing the same or highly related work.
- Level 2: Supervises a larger workgroup of employees performing various types of work.
- Level 3: Supervises employees including provision of coaching and advice to subordinate supervisors.

Examples of Behavioral Indicators:

- Plans, assigns, and monitors work progress.
- Trains employees to do work.
- Evaluates work and gives positive and negative feedback.
- Displays knowledge of legal requirements including applicable Federal and State laws, Administrative Code provisions, Civil Service Commission Rules and Policies, and MOU provisions.

Performance Levels:

Satisfactory

Proficiency in supervision sufficient to supervise a workgroup in terms of task orientation, interpersonal concerns, and personnel administration.

Superior

Proficiency in supervision sufficient to serve as a resource to others and/or represent department position in a public forum.

33. INTERPERSONAL SKILLS – Interacts effectively and courteously with others.

Level of Competency Required by Job:

Level 1: Interact with members of the workgroup, supervision, and/or the

public in a cordial, service-oriented manner.

Level 2: Interact across department lines and with appointed City

officials, and/or members of the public, at times under adversarial circumstances, in a cordial, respectful manner.

Level 3: Interact with appointed and elected City officials, department heads,

representatives of external organizations, and/or the media in a

cordial, effective manner.

Examples of Behavioral Indicators:

- Works well with others toward mutual objectives.
- Does <u>not</u> arouse hostility in others.
- "Disagrees without being disagreeable."
- Elicits acceptance/cooperation from others.
- Affords all individuals respect, regardless of their role or status.
- Effectively addresses concerns of politicians or others who may have their "own agenda."

Performance Levels:

<u>Satisfactory</u> <u>Superior</u>

Behaves in a courteous, respectful, cooperative manner toward coworkers, other City employees, and members of the public.

Facilitates positive interpersonal relations within/among workgroups and toward members of the public. Adept at finding similarities and grounds for cooperation/mutual benefit.

47. WRITTEN COMMUNICATION – Communicates effectively in writing.

<u>Level of Competency Required by Job:</u>

Write notes/e-mails. Completes forms with some open-ended Level 1:

responses (sentences).

Write letters, articles/reports, and/or detailed descriptions of Level 2:

activities/occurrences.

Level 3: Write lengthy reports, instruction manuals, in-depth analyses/

reviews of complex issues and/or articles for publication. Reviews

the written work of others.

Examples of Behavioral Indicators:

Writing includes the necessary information to convey the intended message.

- Sufficiently few errors in spelling, punctuation, grammar to not interfere with the intended message or distract the reader.
- Little editing or re-writing needed to produce a final product.
- Composes materials efficiently.
- Information is presented in a well organized manner.
- Tone and degree of formality are appropriate to the purpose and audience.

Performance Levels:

Superior Satisfactory

Writes material that clearly communicates the necessary information; needs little editing. Precisely uses words and organizes information in a way that enhances presentation of the message. Virtually no editing needed.
