SEASONAL PART-TIME JOB ANNOUNCEMENT

OPEN WATER LIFEGUARD I

(Class Code: 2420-1)

This position is exempt from civil service.*

THIS EXAMINATION IS GIVEN TO FILL SUMMER 2019 OPEN WATER FACILITIES ONLY

SALARY: \$26.41/hour (The salary range is subject to change. You may confirm the starting salary with the hiring department before accepting a job offer.)

DUTIES: Oversees the safety of patrons using open water facilities such as beaches and lakes; patrols open water facilities operating an authorized emergency vehicle; rescues and takes preventative measures to protect patrons using the facility for recreational boating, jet skiing, water skiing, sail boarding, swimming, and other recreational activities; may operate rescue trucks and rescue powerboats to perform these tasks; may conduct swimming, lifesaving, and instructor level courses; enforces regulations and codes; and perform related work. The lifeguard is required to work day and evening hours including weekends. An employee of this class is usually employed only during the summer months and must qualify each year in a performance test.

As a condition of employment, an Open Water Lifeguard I must successfully complete the Open Water Lifeguard I Academy, attend all in-service trainings and must work a minimum of 80 hours (does not include paid training time such as orientation; HO, CPTO/VC or SK Hours) between Memorial Day and Labor Day (5/27/19 – 9/02/19) in order to continue employment with Citywide Aquatics (after Labor Day).

***This position is an exempt, at-will position. The incumbent will not accrue any civil service tenure, contractual employment rights, or due process rights. The incumbent may be removed, without finding of cause, by the hiring authority.**

REQUIREMENTS:

- EXPERIENCE:** None
- AGE:** 18 years of age by April 17, 2019. A valid government issued photo ID is required to take the test and must be presented at the time of test to be admitted. (See section #6 - Department of Homeland Security for types of acceptable identification to bring on test date.)
- CERTIFICATION:** A valid California Driver's License is required and must be presented at the time of the exam to be admitted.
- MEDICAL:** City medical exam required after successful completion of the swim test. Vision must be correctable to 20/20.
- AVAILABILITY FOR WORK:** In the summer season, an Open Water Lifeguard I must be available for no less than three days of work in each week between Memorial Day and Labor Day. These days must remain consistent and must be declared in advance of the summer season. Each Open Water Lifeguard I must work at least 80 non-training hours between the Saturday preceding Memorial Day and Labor Day to be retained as an intermittent employee.
- DOCUMENTS: DEPARTMENT OF HOMELAND SECURITY:** All new city employees must show satisfactory proof of identity and a legal right to work in the United States.

If you have ONE document from CATEGORY A, you will need no further documentation.

A. Documents that show both identity and employment eligibility:

U.S. Passport, Alien Registration Receipt Card (Form I-551, Permanent Resident Card, or Unexpired Employment Authorization Document that contains a photograph (Form I-766, I-688, I-688A, I-688B).

If you DO NOT have documentation from CATEGORY A, you need one document EACH from Categories B and C.

B. Documents that show identity only:

Valid Driver License, D.M.V. ID Card, Current School ID with photograph, U.S. Military Card, Draft

Record or Military Dependent's ID Card.

C. Documents that show employment eligibility only:

Social Security Card, Original Copy of U.S. Birth Certificate by a government agency with a seal, U.S. Citizen ID Card, or I.N.S Employment Authorization Document.

All names and initials MUST match exactly when presenting one document from CATEGORY B and CATEGORY C. This includes, but is not limited to: spelling, titles, initials and surnames. Documents with missing information will NOT be accepted. All documents must be on hand at the test location or submitted to the office immediately following the test.

7. **TESTING CRITERIA:** Candidate must successfully complete a 1000 meter open water swim test with a time of 19:59 or less. The test consists of two (2) circuits of a 500 meter beach entry/out and back swim/beach exit course in protected ocean water. No wetsuit or swim goggles will be allowed or permitted during the swim test. Points for completion of the swim will be awarded as follows:

*This is a scored exam, not a qualifying test. Finishing in the maximum time allowed would yield the minimum passing score of 50 points. Finishing the 1000 meter open water swim under the posted time would yield a higher score.

CANDIDATES MUST RECEIVE A MINIMUM OF 50 POINTS TO BE CONSIDERED FOR THE OPEN WATER LIFEGUARD I ACADEMY.

Candidates completing the Open Water Lifeguard I swim test will be placed on an eligibility list in the order of their score group for a period of six (6) months following the date of promulgation. Applications will be processed on an as-received basis and promulgated to the eligible list accordingly.

8. **PROCESSING:** Candidates will be contacted via email from the eligibility list to attend a part-time orientation. At that time, candidates will be provided information on fingerprinting and security clearance, appointments for City Medical Exam, and other certification requirement.
9. **LIFEGUARD ACADEMY:** New applicants selected for appointment will be required to successfully complete the paid 80 hour Open Water Lifeguard I Academy as well as additional paid in-service training.

Due to uncertainty regarding 2019 summer staffing levels, this test and Open Water Lifeguard I Academy are subject to cancellation at any point in the hiring process.
